**Resolution:**

The Government vide its GR referred at serial No.1 had announced Wind Power Policy-2007 with an operative period upto 30-6-2012. Some clauses of this Policy were amended in 2009 vide GR referred to at serial No.2, with its operative period (i.e. 30-6-12 ) continued as per GR at serial No.1.

Since the tariff control period as decided by the GERC in its Wind Tariff Order No.1 of 2010 dated 30th January, 2010, the Wind Policy-2007 was extended upto 10th August, 2012 Vide G.R. at serial number 3.

The Government vide GR dated 1st October, 2012 referred at Serial No. 4. had extended the operative period of the Wind Power Policy -2007 beyond 10-8-2012 until further orders at the Wind tariff of Rs. 3.56 /kWh, subject to the final outcome of the review petition No. 1243 of 2012 filed with GERC

Meanwhile the GERC vide its order No. 2 of 2012 dated 8th August, 2012, had announced tariff of Wind Energy @ Rs. 4.23 /kWh for the control period from 11th August, 2012 to 31st March, 2016, which was downward revised to Rs.4.15 / kWh vide its order dated 7th January, 2013 in the matter of petition No. 1243 of 2012.

In view of the GERC orders dated 8<sup>th</sup> August, 2012 and 7th January, 2013, and with a view to facilitate the development of Non Conventional Energy sector in the State, pending the formulation of New Wind Power Policy, Government has decided to extend the operative period of the Wind Power Policy-2007 up to 31-3-2013, with Wind tariff of Rs. 4.15 per Unit with effect from 11<sup>th</sup> August, 2012. The other provisions of the Wind Policy-2007 shall remain the same.
